

ANNUAL BUDGET FOR FISCAL YEAR JANUARY 1, 2016 to DECEMBER 31, 2016**

WHEREAS, the Atlantic County Improvement Authority, hereafter, the "Authority", is a political subdivision of the State of New Jersey and an instrumentality of the County of Atlantic established pursuant to N.J.S.A. 40:37A-44, et seq.; and

WHEREAS, the Annual Budget for the Atlantic County Improvement Authority for the fiscal year beginning January 1, 2016 and ending December 31, 2016 has been presented before the Board of Commissioners of the Atlantic County Improvement Authority at its open public meeting of October 29, 2014; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$ 2,198,667.00 and total Appropriations including any Accumulated Deficit if any of \$2,174,617.00 and Total Unrestricted Net Position utilized of \$0.00; and


WHEREAS, the Authority does not have a Capital Budget pursuant to N.J.A.C. 5:31-2.2(c); and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Atlantic County Improvement Authority, at an open public meeting held on October 8th, 2015 that the Annual Budget including all related Schedules of the Atlantic County Improvement Authority for the fiscal year beginning January 1, 2016 and ending December 31, 2016 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease agreements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Atlantic County Improvement Authority will consider the Annual Budget for adoption after approval, of the Annual Budget, by the Division of Local Government Services on December 10th, 2015.


WHEREAS, the Atlantic County Government, hereinafter referred to as the "Lead Agency" has offered voluntary participation in a Cooperative Pricing System for the purchases of work, materials and supplies; and

WHEREAS, the Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

WHEREAS, the Authority desires to participate in the Atlantic County Cooperative, and

WHEREAS, in order to participate the Authority is required to enter into a Cooperative Pricing Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Atlantic County Improvement Authority that Pursuant to the provisions of N.J.S.A. 40A:11-11(5), the Executive Director is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

**RESOLUTION OF THE ATLANTIC COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO A SHARED SERVICE
AGREEMENT WITH ATLANTIC COUNTY TO ADMINISTER THE
COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT GRANT AND
THE HOME INVESTMENT PARTNERSHIP PROGRAM**

WHEREAS, the Atlantic County Improvement Authority, hereafter, the "Authority", is a political subdivision of the State of New Jersey and an instrumentality of the County of Atlantic established pursuant to N.J.S.A. 40:37A-44, et seq.; and

WHEREAS, pursuant to N.J.S.A. 40:37A-54 (a) the Atlantic County Improvement Authority is empowered to provide public facilities for use by any municipality in the County; and

WHEREAS, pursuant to N.J.S.A. 40:37A-54 (i) the Atlantic County Improvement Authority is empowered to provide financial and/or technical assistance for the rehabilitation of low and moderate income housing in Atlantic County; and

WHEREAS, the County of Atlantic, hereafter the "County," was awarded and will enter into a grant agreement with the U. S. Department of Housing and Urban Development (HUD) for an allocation of \$1,033,275.00 in FY 2015 Community Development Block Grant (CDBG) funds; and

WHEREAS, the County was awarded and will enter into a grant agreement with HUD for an allocation of \$432,732.00 in FY 2015 HOME Investment Partnership Program funds (HOME); and

WHEREAS, the County desires to enter into an agreement with the Authority for the Authority to assume responsibility for implementing both the County's CDBG and HOME Programs by administering the program as they have each year since 2001; and

WHEREAS, the Authority likewise desires to enter into an agreement with the County to administer their 2015 CDBG and HOME Grant funds from September 1, 2015 through August 31, 2024 for which services the County will reimburse the Authority \$1,466,007.00; and

WHEREAS, the County has approved the funding levels and eligible fundable projects identified in the FY 2015 Annual Action Plan as listed in the attached summary and as adopted by Resolution No. 335 on June 30, 2015 and submitted to and approved by HUD; and


WHEREAS, the Authority's Office of Community Development has the knowledge and training to provide these services; and

WHEREAS, this contract is classified as services provided between governmental agencies pursuant to N.J.S.A. 40A:11-5(2) and as such is exempt from the public bidding requirements of the New Jersey Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Atlantic County Improvement Authority that the Executive Director is hereby authorized to enter into a contract with Atlantic County effective from September 1, 2015 through August 31, 2024, to administer its 2015 Community Development Block Grant "Entitlement" and HOME Investment Partnership Program for which services Atlantic County will reimburse the Authority in the amount of \$1,466,007.00, contingent upon approval by the Atlantic County Board of Freeholders.

**RESOLUTION OF THE ATLANTIC COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO CONTRACTS
WITH VARIOUS MUNICIPALITIES TO IMPLEMENT
THE FY 2015 CDBG ENTITLEMENT GRANT PROGRAM**

WHEREAS, the Atlantic County Improvement Authority, hereafter, the "Authority", is a political subdivision of the State of New Jersey and an instrumentality of Atlantic County, established pursuant to N.J.S.A. 40:37A-44 et seq.; and

WHEREAS, Title I of the Federal Housing and Community Development Act of 1974, as amended, provides a program of Community Development Block Grants; and

WHEREAS, certain municipalities have signed Cooperation Agreements with the County pledging their participation in the program; and

WHEREAS, the County has entered into a Grant Agreement with the U.S. Department of Housing and Urban Development, hereafter HUD, for FY 2015 funds based on those Cooperation Agreements under Title I of the Housing and Community Development Act, as amended, for Entitlement Grant for \$1,033,275.00; and

WHEREAS, the County will enter into a contract with the Authority to administer and oversee the Entitlement Grant and implement portions of it; and


WHEREAS, the County has approved the funding levels and eligible, fundable projects from those participating Municipalities in the FY 2015 Annual Action Plan adopted by Resolution No. 335 on June 30th, 2015, and submitted to and approved by HUD as identified in the attached summary sheet; and


WHEREAS, the County, in the future, may adopt amendments to the Action Plan in accordance with their Citizen Participation Plan redirecting the funds allocated in one or more of the participating Municipalities to other eligible projects within that Municipality; and

WHEREAS, it is necessary for the Authority to enter into Contracts with participating Municipalities under which the Municipalities will implement their portion of the Entitlement Grant; and

WHEREAS, these contracts are classified as services provided between governmental agencies pursuant to N.J.S.A.40:A:11-5(2) and as such are exempt from the public bidding requirements of the New Jersey Local Public Contracts Law;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Atlantic County Improvement Authority that the Executive Director is hereby authorized to enter into contracts with each of the 20 participating Municipalities to undertake the projects outlined in the 2015 Annual Action Plan, and is authorized to enter into contracts in accordance with those municipalities to undertake projects identified in any subsequent amendments to that plan adopted by Atlantic County as eligible activities under 24 CFR Part 570 Subpart C, and to distribute funds up to the maximum amount identified above, as stipulated in the aforementioned agreement.
