WHEREAS; based on the information contained in the proposals, ascertained from the interviews and our first hand knowledge related to experience, capabilities, level of proposed service, familiarity with Atlantic County and relationship with the US Department of Housing and Urban Development, staff recommends the firm of Mullin & Lonergan Associates for an amount not to exceed \$35,300.00; and
